The following is the requirements under Ontario Business Corporations Act:

- 1. The registered office must be located in Ontario and must be a physical address, not a P.O Box (residential addresses are acceptable).
- 2. A director must be an individual, at least 18 years old, not bankrupt, and not declared mentally incapable by a court.
- 3. Note: Ontario has removed the Canadian residency requirement for directors as of 2021-07-05.


